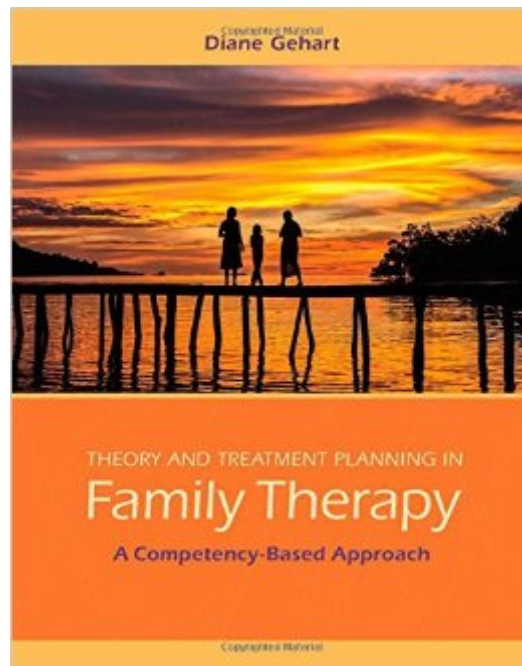

As a LMFT and Approved Supervisor (now retired), I think this is a much needed and superior text. In particular, I like the emphasis on research—the inclusion of evidence-based practice, common factors research, and evidence-based treatments material. In my opinion an outstanding text. In regard to the Kindle edition (I took advantage of, and appreciate the 7-day trial of the Kindle book), I was comfortable with the organization and navigation features, but the font size was too small for these old eyes, and unfortunately there does not appear to be a provision to change the font size in the Kindle display, as there is in other books. If the capability to change the font size could be added to this Kindle book, I think it would contribute to more sales of the Kindle edition (I know that the view can be magnified on the screen by spreading it, but this is too awkward for reading in my opinion.)

I used this textbook in a Master Degree program. The book was very easy to comprehend (which is sometimes rare at the Master's level). The text was aligned in great organized manner and the index was very helpful. Great book for class!
